Spill / leak Procedures: If spilled, sweep up using an approved toner vacuum with a 0.5 micron filter or smaller, such as the Atrix AAA Toner Vacuum or 3M Toner Vacuum. Reproductive Toxicity: Manganese and its organic compounds: There is a study showing that prolonged inhalation of excessive amounts of manganese may cause adverse effects on the fertility of male workers. However, normal use and handling of this product as intended does not result in inhalation if excessive amounts of manganese.

Carcinogenicity: Carbon Black: IARC 2B (Possible human carcinogen based on animal testing). Not listed in NTP, OSHA(USA) regulation, California Proposition 65 and Annex I of EU Directive 67/548/EEC.
